Discussion: Does America Lead in Quantum?

The United States is widely described as the world leader in quantum technology. But quantum is not a single race. The United States appears strong across most approaches to quantum computing, while China, through a centralized state program, is close behind in superconducting systems and leads outright in quantum communications. America's advantage rests on a decentralized, bottom-up ecosystem of private firms, universities, national laboratories, public funding, and international talent. That model has produced major milestones, but it raises a hard question about whether fragmented investment can hold the line while the foundational research base faces budget pressure. This conversation tests conventional assumptions head-on, asking where the United States actually leads, where it does not, which advantages matter most for national and economic security, and what it would take to sustain them.

Session I: Spectrum: WRC-27 Countdown and Policy Developments

This discussion will focus on what's actually contested heading into WRC-27 in Shanghai. IMT identifications in 4400-4800 MHz, 7125-8400 MHz, and 14.8-15.35 GHz pit mobile growth against federal incumbents, and force the deeper question of whether new mid-band gets allocated as exclusive licensed spectrum (China's preference), opened for unlicensed and dynamic sharing (the US model), or carved into hybrid arrangements (where Europe and the UK are still landing). Agenda Item 1.14's proposed MSS allocations in the 2 GHz bands sit at the center of the direct-to-device fight. The satellite cluster, covering ESIMs at 47-51 GHz and non-GSO FSS gateways at 51.4-52.4 GHz, will shape how non-geostationary systems scale. With CITEL, CEPT, and APT positions still forming roughly eighteen months out, the dinner will surface where industry, agencies, and allies are aligned and where they aren't.

Session III: Laboratories of Democracy or an American Brussels? States and Digital Regulation

Policy debates often treat digital platform regulation as a European story, built around the DMA, the DSA, and the AI Act. That story is now coming to the US, especially to the states. On competition, California's BASED Act would have barred the largest platforms from favoring their own products before it died in a state Senate committee this spring. New York's 21st Century Antitrust Act, already passed by its Senate more than once, would write a European-style abuse-of-dominance standard into state law. On governance, more than a dozen state privacy laws are now in force, while Colorado's first-in-the-nation AI Act was delayed twice and then scaled back before ever taking effect. The questions are whether any of them work, and at what cost. Two years on, the

evidence on the DMA cuts both ways. Some studies find that removing self-preferencing did little to move consumers toward rivals, and businesses such as airlines and hotels report new costs, while supporters point to gains in interoperability and market access and argue enforcement is too young to judge. The state laws face the same test, whether they deliver real protection or mostly add compliance cost and fragmentation. This dinner asks whether the states are providing protections Washington has not, or importing the fragmentation that critics say is hobbling Europe.
