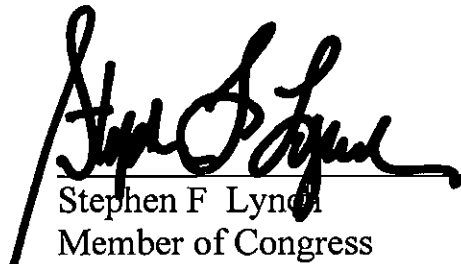
Dear Mr McCumber
